1. The appeal filed under section 91 of the Trademarks Act, 1999 against the order dated 28/06/2010 allowing the Registration No.963781 in class 03 registered in the name of respondent No.1.
2. The learned counsel for the appellant states that the trademark which was registered in the name of respondent No.1 has not been renewed even after the expiry of grace period. It is stated by her that Trademark application was filed on 16/10/2020. The registration certificate was issued on 18/10/2019. The grace period for renewal of the mark being one year has expired on 18/10/2020. As per the status report, the mark has not been renewed as on today. Under these circumstances, the

learned counsel for the appellant states that the appeal be disposed of and liberty be granted to revive the Application if the mark of the respondent No.1 is renewed under any reason. Accordingly the appeal is disposed of. No costs.
